(1) On 18 May 2020, a total of 20,011,884 share options were offered to certain eligible employees of the Company pursuant to the terms of the Discretionary Long-Term Incentive Plan (please refer to the announcement dated 18 May 2020). As at 30 June 2020, a total of 19,957,709 options have been accepted (the remaining 54,175 share options were either declined or not accepted).

(2) On 4 December 2019, a total of 9,325,375 share options were offered to certain eligible employees and directors, subject to their acceptance, pursuant to the Discretionary Long-Term Incentive Plan (please refer the announcements dated 5 December 2019 and 8 January 2020). As at 31 January 2020, a total of 9,201,728 options were accepted and hence granted (the remaining 123,647 options were either declined or not accepted). As at 30 June 2020, a total of 19,059 options were cancelled and hence the total number of options granted was reduced to 9,182,669.
